# 6. BOARD MEMBER REPORTS

## President (Rick Quinn)

Rick attended the OMHA meeting on Dave's behalf. The Bob Beaumont bursary was discussed and one of the three applicants will be selected.

For Rowan's law sign off forms, they must be uploaded.

Confirmation of Gender Identity training must be submit with team rosters. Coaches have to indicate that they showed the video to players.

The OMHA is looking for centres to have a head trainer at level three, and they would have to attend a course specific to head trainers. It is not compulsory.

Update on the Atom pathway - it will not be cross ice hockey, but not playing at Christmas, March break or long weekends.

\$35 per rep team must be sent to MPS for the next meeting. Kelly would like an invoice prior to writing the cheque.

The mileage sheet for referees remains the same as last year.

Muskoka Rock will have two novice teams this year, both local league.

The Local League silver still will be held @ Highland Storm - November  $30^{\rm th}$  for Atom & Pewee, December  $7^{\rm th}$  for Bantam & Midget.

Rick advised that the PSHC will not agree to play any games in Wilberforce. The PSHC is willing to pay the fine as opposed to having families travel that far.

## Vice President (James Cox)

James reported that Jen Harris did a great job at the Rep scheduling meeting and getting everything organized.

## Treasurer (Kelly Hergaarden)

Kelly reviewed the account balances.

Kelly updated the board on players that still had outstanding registration balances. The Board agreed that they will not be allowed to play until paid in full.

There are approximately 272 players registered. We have \$22,000.00 outstanding, but have yet to receive the registration from the \$150 players. At this point, it does not appear that the change in the family rates resulted in any savings for the club.

The memo from OMHA regarding the requirement to wear helmets was circulated. The new OMHA White book will be here end of September, but is currently online.

We have had one suspension so far in regards to a fight in the Bantam exhibition game.

Discussion on a Rep coach requesting ice time through Jen. All requests for games and otherwise must go through Tyler first.

Jen will be working with Chris to prepare for and attend the local league scheduling meeting. Also working on IP scheduling.

The major novice team will be practicing Wednesdays at 4pm in town.

Rosters are all in with a couple of players who have outstanding balances. The peewee team will be doing dryland training at Georgian Nordic and submit the appropriate paperwork. Paperwork was also complete for a team apparel request within the team allowable expenses.

The Board discussed team allowable expenses and eventually came to an agreement that Motions and approval are not required at the Board meetings if the requests fall within the team allowable expenses and within the funding breakdowns provided to teams by the treasurer. Kelly will be meeting with all team managers (Rep and local league) to explain funding, budgets and proper process.

The Bantam and Midget teams want local league APs approved asap so that they can go to tournaments. This can't be done until they are rostered on a local league team.
